



UNDER 18 STUDENT CARER FORM

Visa condition 8532 requires that under-18 year old students maintain suitable accommodation, support and general welfare arrangements. The Department of Immigration and Citizenship (DIAC) permits under-18 year old students to stay with a parent or suitable relative or, if this is not possible, in accommodation approved by their education provider.

Option A: University-approved accommodation

- If UWA approves the accommodation, support and welfare arrangements, we will sign a Confirmation of Appropriate Accommodation/Welfare Arrangements (CAAW) letter, which the student will need to submit as part of the visa application.
- UWA can only approve the arrangements for the period the student is staying in the approved accommodation. If the student is to be in Australia for any period before or after the dates on UWA's CAAW letter, then additional welfare arrangements must be approved by DIAC for this period before the visa is issued.
